Structure, Governance & Management

Constitution

The Charity is an unincorporated association. The Trust was granted charitable status by OSCR on 31 December 2010.

Appointment of Trustees

The management committee, which normally meets on a monthly basis, are the charity's trustees. Trustees are elected at the Annual General Meeting which is normally held in November. Under the constitution, there must be a minimum of three and not more than nine elected trustees. The trustees may co-opt a further three trustees if they consider it would be in the interests of the Trust to do so.

Future AGM Timing

In order to hold the AGM nearer the end of the financial year, on the 26th of November 2016 the trustees resolved that from 2017, the AGM would be held in May. The next AGM therefore will be in May 2017.

Objectives & Activities

Charitable purposes

The aim of the Trust is to commemorate the life of Joanna Walters by giving grants to causes that she would approve of.

Mission Statement

In memory of Joanna Walters, and to celebrate her life and achievements as an inspirational person, teacher and motivator, the Trust will provide opportunities to help people enrich their lives and the lives of others, through sport, outward bound, educational and environmental projects, both at home and abroad.

The Trust is an approved Scottish Charity, regulated by the Office of the Scottish Charity Regulator. It has nine appointed trustees. The Trust is actively fundraising and collecting donations in Joanna's memory.

Activities

The Trust provides opportunities to help people enrich their lives and the lives of others, through sport, outward bound, educational and environmental projects, both at home and abroad.

Achievements & Performance 2015-2016

The Trust made ten grants to various individuals and organisations, totalling £26,709, all in line with our mission. The Trust also raised £12,317 to fund future projects.

Financial Review

Receipts on the unrestricted fund were £12,317:

- £4,579 Receipts from fundraising activities, including the Caprington Big Day Out, donations from Amanda Paul's wedding and the Capenoch Garden Opening.
- £666 Receipts from other charitable activities (a late payment related to the 2014 JWT Ball).
- £5,022 Voluntary Donations received from friends, family and other donors interested in the work of the Trust.
- £2,050 Receipts from the sale of wooden table games, calendars and Mr Roberelli children's CDs.

Payments for the year were £30,570. This consisted of:

- 10 grants, made to:
 - Feedback Madagascar: £18,000.
 - Grampian Disability Sport: £530
 - Monymusk Playpark Improvement fund: £1000
 - Outward Bound Trust: £1,660
 - Mormond Thistle Football Club (Grant originally awarded in 2014-15): £1000
 - Fyvie Guide House Appeal (Grant originally awarded in 2014-15): £1000
 - Bodham and District Community Association (Grant originally awarded in 2014-15): £500
 - Kerry MacPhee, Scottish international athlete from South Uist: £1300
 - Computers and Integration (Grant originally awarded in 2014-15): £719
 - St Fergus Primary School, for leaver's grant (Grant originally awarded in 2014-15): £1000

TOTAL: £26,709

- Purchase of stock (calendars, games, etc): £1,210.
- Payments related to organising charitable activities: £2,597 (all these costs are attributed to the Caprington Big Day Out, consisting of: £615 for marquee and portaloo hire, £1,520 for catering and £461 for entertainments).
- Expenses for fundraising activities: £54 (this is a JustGiving administration fee which allows the Trust to collect donations online, as required for specific fundraising activities).

At 31st March 2016, monies available for use with future grants were £49,386.23, consisting of:

- £6,766.64 (held in the bank)
- £42,619.59 (invested with ethical microfinance provider Oikocredit).

Plans for Future Periods

The Trustees reviewed the achievements of the **Feedback Madagascar** project as detailed in the grant report which was produced for the JWT by Feedback Madagascar (SC023568), outlining the first two years of activity. The trust granted them £16,900 in 2013-14 and following the success of the first phase, awarded a further grant of £18,000 in 2015-16 to continue the work for a further year. Both grants have funded a major project, "Seeds of Change", which has delivered lasting educational, environmental and economic benefits to 21 communities (796 households) in rural Madagascar, one of the world's poorest countries. The project provides: seeds for food production and income generation; training in seed and crop management; training and support in agroforestry techniques, leading to 200kms of fire barriers and 85 hectares of sustainably-cultivated land; 200 tons of compost; and a not-for-profit community "seed bank", containing over 200,000 seedlings for future use. The project improved communities' income, nutrition and long-term economic stability and has continued to thrive into phase II.

In addition to the grant report, we were fortunate to enlist the support of Katheryn Harrison (a friend of the JWT) in assessing the project's achievements first hand when she visited in March 2016. Her independent monitoring of the Trust's expenditure and the project's achievements detailed in the grant report confirmed the value of the project to the Trustees. In view of both Katheryn's visit report and the grant report, the Trustees were pleased to confirm that a further donation of £18,000 will be made in the FY 2016/17 to support phase III. Ongoing support to this major charitable partner will again be reviewed at the next AGM, subject to achievements in the interim and any proposal from Feedback Madagascar for funding support beyond FY 2016/17.

The Trustees also reviewed the following grants to **good causes in Aberdeenshire** which will be made in the FY 2016/17:

- Strathdon Primary School: £850. This will be used to provide opportunities for the pupils of Strathdon primary to develop self-confidence and a sense of purpose and achievement. They aim to achieve this whilst providing structure and training through the Adventure Service Challenge scheme, a precursor to the Duke of Edinburgh's Award. The funds will pay for outdoor learning tutors, first aid training and ASC record cards.
- Networks of Wellbeing Ltd: £1,700 (SC021861). This project will work with pupils and staff from the Support for Learning Department team within the Gordon Schools, Huntly, to deliver a cycle based project including basic bike maintenance prior to led cycle rides in the local countryside. converting toddlers bikes to 'balance bikes' to be donated to local nursery groups, as well as providing training for NoW staff to upgrade bike maintenance qualifications from Velotech Silver to Gold Award level. This project aims to address a gap in provision for pupils with additional needs with NoW agreeing to deliver the project within the SFL Department in the school.
- Logie Coldstone Primary School: £900. Logie Coldstone is a very small school with only 22 pupils in all and team sport is thus not an option for the school. To bring the children together in a joint outdoor sporting activity and make the most of the area's natural resources, this grant will pay half of the costs to take the pupils to their local ski centre, the Lecht. All 22 pupils from P1 to P7 will take part in the 2-day ski trip which includes ski instruction.

- Aboyne Primary School: £900 cycling. The grant from the Jo Walters Trust will support and improve the extracurricular cycling activities on offer at Aboyne Primary School, including mountain biking, cycle maintenance and repair and safety awareness. By supporting extracurricular participation in cycling and increasing awareness of bike maintenance and repair, it is hoped to encourage more young people at the school to cycle more often and to spread this ethos to families, bringing all the benefits of frequent exercise and increasing outdoor activity in this spectacular part of Scotland.
- Aberlour Trust forest school: £1,640 (SC007991). The Aberlour Trust is a Scottish children's charity, providing help to over 6000 of Scotland's most vulnerable children, young people and their families each year, We have approved them for a grant which will pay for a staff member to undertake the Level 3 Forest Schools Practitioner award through Forest Schools Scotland. Once trained, staff will then be qualified to take small groups of young people into local forests, where they will get the opportunity to learn, play and explore outdoors, something many of the young people who are helped by the Aberlour Trust struggle to access but that their peers take for granted. The grant will also pay for 5 sets of waterproof clothing and footwear, plus rucksacks for use in forest environments.

The Trustees also reviewed the following grants which were awarded for a **maths competition** set up following a suggestion at the 2015 AGM in recognition of Jo's chosen career, with the aim of diverting grant money into education, and particularly innovation in education. It was agreed that six grants will be awarded in FY2016/17:

- Gateway Academy in Blackpool, Practical Maths through Cooking £750: Linda Balshaw, from the Gateway Academy in Blackpool, is going to start an after-school enrichment program to counter her pupils' belief that maths has no use in the real world. With measuring equipment, cooking, and planning pricing for shopping trips, they'll soon discover that not all mathematicians are teachers! This first year it will be Year 2 and Year 3 students who benefit, and many of the sessions will take place outside, which will be a positive change as many live in rented accommodation with limited outside space.
- Walthamstow School for Girls, Maths Cafe £500: Walthamstow School for Girls is going to
 fulfil a long-held dream of starting a Maths-Cafe each half term, led by Sally Robinson. Whilst
 eating Algebrownies and Mathemallows, the whole school will appreciate the Mathematical
 decor, puzzles and competitions, raising the profile of maths in the school. The organising
 team will use maths in planning and running the cafe as a business, in the hope that the cafe
 will eventually self-fund and even generate a profit for charity.
- Vinney Green Secure Unit, Physical Velcro Aids £750: teaches young people on remand or sentenced for an offence, who often do not respond well to traditional methods. They are going to implement a physically interactive teaching system to engage their students better. Using velcro, facts, questions, diagrams and more will be attached to the walls, enabling displays to change regularly and even within a lesson, as students choose their own questions and make links in a physical way.
- Crooksbarn Primary School, Maths Library £600: Gavin Brownless from Crooksbarn Primary School in Norton is going to buy resources for a Maths library. This will allow all year 1s and year 2s to take Maths games home for a week at a time and to engage their families in the mathematical learning. Families already are encouraged to read together; now they will be

- able to develop their numeracy, problem solving and Mathematical knowledge together whilst having fun.
- East Midlands Association of Teachers of Mathematics (ATM), Royal Institution masterclass for KS3 at National Space Centre - £500: Robert Smith, from the East Midlands ATM, is going to use funding to further support the Royal Institution lectures, to enrich KS3 students learning, as well as running a session for PGCE students and supporting a session for experienced teachers at the ATM Maths conference.
- Wolverhampton Home Education Group, Building Giant Mandalas £220: Jennifer Williams
 from Wolverhampton Home Education Group is going to enthuse local families on World Maths
 Day, by enabling them to build giant mandalas as a Mathematical Art installation at a local
 community centre. This should encourage them to approach their mathematical studies in a
 more creative way and we look forward to seeing some exciting pictures of the creations in due
 course.

At the AGM on 26 November 2016, the Trustees also agreed:

- To trial the award in 2017 of outdoor education grants in Ayrshire; there is an acute need for this sort of activity in depressed areas of Ayrshire and correspondingly much of the recent fundraising activity has taken place in Ayrshire; it was decided that the total value of the grant be agreed subsequent to a meeting with the Outward Bound Trust in early 2017.
- That refocussing the Aberdeenshire Grants towards outdoor learning in the last AGM has been worthwhile and has brought forward a particularly relevant batch of applicants in the 2016 applications round; we should continue to offer focused grants in 2017.
- That the Maths grant, which was a 2016 innovation designed to offer three grants of up to £1,000 to support projects which help and inspire pupils to engage with mathematics was very popularly received with some genuinely novel ideas being proposed. In the event six grants were awarded with the award budget being exceeded by £300, however this allowed the Trust to grant awards to more schemes than had been originally anticipated; it is proposed to continue this in 2017 along similar lines.
- Due to non-availability of the venue, the "Caprington Big Day Out" fundraising event will not take place in 2017. It was proposed that a 2018 event would be discussed in the next AGM.
- The AGM committed to switching our current account to CAF in order to allow the Trust to bank online.
- That future AGMs will take place in May, to be more in line with the end of our financial year.

Independent Examiner's Report

Independent Examiner's Report to the Trustees of The Jo Walters Trust

I report on the financial statements of the charity for the year ended 31 March 2016, which are set out on the next three pages.

Respective responsibilities of Trustees and Examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 ("the 2005 Act") and the Charities Accounts (Scotland) Regulations 2006 (as amended) ("the 2006 Regulations"). The charity's trustees consider that the audit requirement of Regulation 10(1)(d) of the 2006 Regulations does not apply.
